
# Small Business Prime Contracting Dollars Breaking Records in FY2019

Small business is expanding and contributing to the economy at a record-breaking level. By better competing for and winning federal contracts, small businesses have supported about 677,000 jobs, driving job creation, innovation and growth on a local, regional, and national level.



Focus is on **improving small business** industrial base (measured by the number of unique small business vendors in top 100 NAICS doing business with the federal government). This measure has **decreased by almost 8%** (FY 2019 versus FY 2018).

## **Historic Highs**

- Small-disadvantaged businesses received 10.29% (\$51.6 B) of all small business eligible contracting dollars - highest percentage ever.
- Service-disabled veteran-owned contract dollars achieved 4.39% (\$22 billion) of all eligible contracting dollars. Federal government has exceeded its goal for seven consecutive years. In FY 2019, it reached a historic high.
- Woman-Owned small businesses exceeded the goal by achieving 5.19%\* (\$26 billion) of eligible contracting dollars – highest amount ever and second time in the past seven years.

### FY2019 Highlights

- Federal government exceeded the small business contracting goal for the seventh consecutive year.
- Awarded record breaking \$132.9 billion in prime contracts to small business.
- 26.5% of all federal small business eligible dollars were awarded to small firms.
- Over 72,000 small business prime contractors received average awards of \$1.8 million.

## **Outreach Efforts**

- Continued promotion of all programs to procuring federal agencies and small businesses.
- Conducted training sessions nationally to educate contracting officers on requirements for the SBA 8(a) Business Development, HUBZone, WOSB, and SDVO programs.
- Educated small businesses on federal contracting.
- **Participated in outreach** through the National 8(a) Association, Native American Contractors Association, and the Native Hawaiian Organization Association.
- **Partnered with Women Impacting Public Policy and American Express** on **ChallengeHer**, which boosts contracting opportunities for woman-owned small businesses. In its seventh year, this program has:
  - Educated over 21,000 women entrepreneurs
  - Hosted 70 events across the country for woman-owned small businesses and government officials.
