
Small Business Prime Contracting Dollars Breaking Records in FY2020

Small businesses are expanding and contributing to the economy at a record-breaking level. By competing for and winning federal contracts, small businesses have supported about 699K jobs, driving job creation, innovation, and economic growth on a local, regional, and national level.



An area of focus is on **growing the small business** industrial base (measured by the number of unique small business vendors in top 100 NAICS doing business with the federal government). This measure has **decreased by almost 2.0%** (FY 2020 versus FY 2019).

Historic Highs

- Small-disadvantaged businesses received 10.54%*(\$59.0 billion) of all small business eligible contracting dollars – the highest percentage ever.
- Service-disabled veteran-owned small business contract dollars reached 4.28%* (\$23.9 billion) of all eligible contracting dollars.
- The Federal government has exceeded its goal for eight consecutive years - the highest service-disabled veteran-owned small business dollars amount ever.
- Women-owned small businesses obtained 4.85%* (\$27 billion) of eligible contracting dollars – the highest women-owned small business dollars amount ever.
- HUBZone small businesses obtained 2.44%
 (\$13.6* billion) of eligible contracting dollars –
 the highest HUBZone small business dollars
 amount ever.

FY2020 Highlights

- Federal government exceeded the small business contracting goal for the eighthconsecutive years.
- Awarded a record-breaking \$145.7* billion in prime contracts to small business.
- 26.01%* of all federal small business eligible dollars were awarded to small business firms.
- Over 69,000 small business prime contractors received awards, averaging \$2.1 million dollars in awards per firm.

Outreach Efforts

- Continued **promotion of all programs** to procuring federal agencies and small businesses.
- Conducted **training sessions nationally** to educate contracting officers on requirements for the SBA 8(a) Business Development, HUBZone, WOSB, and SDVO programs.
- Educated small businesses on federal contracting.
- Participated in outreach through the National 8(a) Association, HUBZone Contractors National Council, Native American Contractors Association, and the Native Hawaiian Organization Association.
- Partnered with Women Impacting Public Policy and American Express on ChallengeHer, which boosts contracting opportunities for woman-owned small businesses. In its seventh year, this program has:
 - Over 13,000 women entrepreneurs were educated through this program through October 2020.
 - Hosted 82 ChallengeHER event through October 2020 across the country for women-owned small businesses and government officials.

Advocating for Small Business

- Implemented changes to simplify HUBZone regulations, mitigated risk to the government and added new HUBZone communities including "Governor-designated covered areas".
- Consolidated All Small Mentor Protege and 8(a) Business Development Mentor Protege programs into one.
- Launched certification of Woman-Owned Small Businesses and Economically Disadvantaged Women-Owned Small Businesses.
