

## 2002 Small Business Profile: ARKANSAS

The events of 2001 posed critical challenges to the state of Arkansas as well as the nation. Nevertheless, the economic health of Arkansas benefited from its small businesses (those with fewer than 500 employees). Small businesses are an important source of new jobs in the state. The small business sector also provides opportunities for women and minorities and is a continual source of innovation and invention. These qualities proved to be economically beneficial to Arkansas last year.

**Number of Businesses.** The number of employer businesses in 2001 increased by 0.5 percent, and the number of self-employed individuals increased by an estimated 17.3 percent. Employer businesses numbered 59,757 in 2001. The most recent data by firm size (1999) indicate that 97.0 percent of businesses in the state were small. In 2001, an estimated 101,552 individuals were self-employed. **Women-Owned Businesses.** Women owned 22.0 percent of the state's firms in 1997 and generated \$6.5 billion in revenues. Of the state's total women-owned businesses, 16.7 percent had employees. (Source: U.S. Dept. of Labor, Bureau of Labor Statistics, U.S. Dept. of Commerce, Census Bureau)

**Minority-Owned Businesses.** The latest (1997) Census data indicate that minority-owned businesses totaled 13,000 and made up 6.7 percent of the state's businesses, of which 16.2 percent were employer firms. (Source: U.S. Dept. of Commerce, Census Bureau)

**Business Turnover.** In 2001, there were 3,990 new employer firms, or 14.7 percent fewer new employer firms than in 2000. Business bankruptcies totaled 290 in 2001, an increase of 11.1 percent over 2000, while business terminations amounted to 4,746, a decrease of 15.0 percent over 2000. **Employment.** Small businesses employed 466,928 or 48.9 percent of the state's 954,948 employees (non-farm private sector) in 1999. The industry with the most small business employees was retail trade. The total number of small employer firms in 1999 was 50,650 (Table 1). (Source: U.S. Dept. of Commerce, Census Bureau, Statistics of U.S. Businesses)

**Small Business Income.** Proprietors' income—a partial measure of small business income—totaled \$5.9 billion in 2001, an increase of 8.6 percent over 2000. (Source: U.S. Dept. of Commerce)

**Finance.** Often, small businesses use commercial lenders and rely on local bank services. Over the last five years, the number of banks in the state has decreased. The Office of Advocacy has identified the small-business-friendly banks within the state and has published the names in its banking studies report. (See Table 2 for the number of banks by asset size.)
