## **SBA’s Deadline For Physical Damage Disaster Loans For Private Non-Profit Organizations Is July 18**

**ATLANTA** – The U.S. Small Business Administration reminds certain Private Non-Profit Organizations (PNPs) that do not provide critical services of a governmental nature of the deadline to submit disaster loan applications for damages caused by severe storms, tornadoes, flooding, mudslides and landslides on April 3 – 4, 2008. The deadline to file an application for physical damage is **July 18, 2008**

PNPs located in Anderson, Crittenden, Fleming, Fulton, Hancock, Hopkins, Lewis, Livingston, McLean, Nicholas, Ohio, Spencer and Woodford counties in the Commonwealth of Kentucky are eligible to apply to SBA. Examples of eligible non-critical PNP organizations include, but are not limited to, food kitchens, homeless shelters, museums, libraries, community centers, schools and colleges.

“PNP organizations are urged to contact their county emergency managers to obtain information about local briefings. At the meeting, PNP representatives will provide information about their organization,” said Frank Skaggs, Director of SBA Field Operations Center East.

This information will be used to submit a “Request for Public Assistance” which FEMA uses to determine if the PNP provides an essential governmental service and meets the definition of a “critical facility.” Based upon that conclusion, FEMA will either refer the PNP to SBA for disaster loan assistance or possibly provide a “Public Assistance” reimbursement grant for eligible costs.
