New G845 Mailing Instructions

Beginning **June 22, 2009**, all paper G-845 "Document Verification Request" forms must be filed to DHS/USCIS Status Verification offices located in San Francisco, CA., Los Angeles, CA and Buffalo, NY based on jurisdiction, as shown below.

Where to File:

Important: Any Form G-845 submitted at an incorrect location will be rejected.

Agencies located in AK, American Samoa, AZ,, CO, DC, Federation States of Micronesia, FL, Guam, HI, ID, IL, IN, KS, MH, MD, MT, NE, NV, NJ, NM, ND, MP, OH, OK, OR, Palau, PA, SD, TX, UT, VA, WA, and WY must file their Form G-845 with the USCIS Verification Office using the following address:
