SBA:**Goaling Achievement**

The Environmental Protection Agency (EPA) met 3 of their 5 prime contracting goals missing Women Owned Small Business and HUBZone.

Fiscal year 2009 prime contracting achievement saw increases over FY2008 in Small Business, Small Disadvantaged Business, and Service-Disabled Veteran Owned Small Business. EPA FY2009 achievement declined from FY2008 in Women Owned Small Business and HUBZone.

EPA regularly attended the SBA chaired Small Business Procurement Advisory Council meetings hosted at the SBA.

American Reinvestment and Recovery Act Contracts

Since enactment of ARRA, EPA has directed 59.1% of their Recovery Act funds toward small businesses.
