

## **HUBZone Program Benefits for Tribal Communities**

The HUBZone program fuels small business growth in historically underutilized business zones with a goal of awarding at least 3 percent of federal contract dollars to HUBZone-certified companies each year.

Becoming HUBZone certified makes your business eligible to compete for the program's set-aside contracts. To qualify for the HUBZone program, your business must:

- **must:** Be a small business according to SBA size standards
- Be at least 51 percent owned and controlled by U.S. citizens, a community development corporation, an agricultural cooperative, an Alaska Native corporation, a Native Hawaiian organization, or an Indian Tribal Government
- Have its principal office located in a HUBZone
- Have at least 35 percent of its employees living in a HUBZone

## **Tribal Community Participation in the HUBZone Program**

- All Federal Indian Lands are considered HUBZones. Over 500 certified HUBZone firms are located in Indian Lands.
- There are nearly **100 tribally owned, certified HUBZone firms**. They were awarded over **\$766 million in federal contracts** in FY 2022.
- There are over **300 Native American-owned HUBZone certified firms**. They were awarded over **\$1.3 billion in federal contracts** in FY 2022.

## **Eligibility Options if Your Business Is Tribally Owned**

Tribally owned businesses are at least 51 percent owned by one or more Indian Tribal Governments, or by a corporation that is wholly owned by one or more Indian Tribal Governments.

If your business is tribally owned, you may choose from one of the two options below to apply for HUBZone certification:

- 1. Certify that when performing on a HUBZone contract, at least 35 percent of the employees performing on that contract will reside within a reservation governed by the Indian Tribal Government owners or reside within an adjacent HUBZone.
- 2. Use the standard eligibility requirements, including having your principal office located in a HUBZone and having at least 35 percent of your employees living in a HUBZone.
