Comments:
Graded Agency:
The Department of Energy (DOE or the Department) obligated \$1.2 billion (prime) or 5.25% and \$7.2 billion (subcontract) or 49.4% of eligible dollars; unfortunately, we did not attain our small business goals. However, DOE achieved a significant impact for the benefit of the small business community through obligating \$8.5 billion (prime and subcontract) or 36% of our FY2014 \$23.3 billion procurement base. In addition, the Department's executive leadership issued communication encouraging increased spending with small businesses and implemented procurement policies favorable to the small business community. We appreciate the Peer Review Committee recognizing these and other efforts by giving us a grade of 96.3%.
However, despite our efforts, the Department earned a failing grade on our scorecard. This reflects, in large part, to the Department's unique long standing business model, whereby 85% of our total procurement bases go towards the operation of our site and facility management contractors (M&O). The Department is unique because it is the only agency with M&O contracts, and FAR Subpart 17.6 was written specifically for DOE. While the Department did not make the 6.59% prime contract goal, as noted above, DOE did obligate over a third of its procurement dollars to small businesses.
