Comments:

Graded Agency:

We are very proud to have achieved and exceeded our overall Small Business Goal along with three of the four socio-economic goals, Small Disadvantaged Business (SDB), Women Owned Small Business (WOSB), and Service-Disabled Veteran Owned Small Business. We continue making efforts to meet our HUB Zone goals through various vendor outreach, as well as communicating with acquisition staff to seek out potential HUB Zone vendors as part of market research. We also exceeded all four socio-economic subcontracting goals for FY20. These achievements reflect our continued commitment to advancing the interests of both the prime and subcontracting small business programs. In accordance with reporting and public notification requirements of the Small Business Act, the department awarded prime contracts to Puerto Rico businesses in the amount \$664,584. For purposes of determining compliance with the goals for procurement contracts this amount has been doubled to \$1,329,168 and is reflected by the total dollars in the Fiscal Year 2020 Scorecard. We also awarded prime contracts to the US Virgin Islands in the amount of \$48,332, for which the amount has been doubled to \$96,664 (where double credit was extended to the US Virgin Islands, American Samoa, Guam, and the Northern Mariana Islands by the National Defense Authorization Act for FY2020).
