Report Summary

The Small Business Act (the Act), in Section 15 U.S. C. § 644(k)(16), requires the Agency Offices of Small Disadvantaged Business Utilization (OSDBUs) to submit a report on training provided and training and travel costs as a percentage of the OSDBU budget to the Committee on Small Business of the House of Representatives and the Committee on Small Business and Entrepreneurship of the Senate. Under 15 U.S.C. § 644(k)(16), each agency OSDBU:

- "(16) shall submit, each fiscal year, to the Committee on Small Business of the House of Representatives and the Committee on Small Business and Entrepreneurship of the Senate a report describing-
- (A) the training provided by the Director under paragraph (13) in the most recently completed fiscal year.
- (B) the percentage of the budget of the Director used for such training in the most recently completed fiscal year.
- (C) the percentage of the budget of the Director used for travel in the most recently completed fiscal year; and
 - (D) any failure of the agency to comply with section 637, 644, 657a, or 657f of this title;"

In order to facilitate this reporting, the Small Business Administration (SBA) has compiled the agency reports on training and travel costs for FY 2020 and provided a summary table of such reports. Where the agencies separately identified the dollar value of the training and travel costs, it is provided in parentheses. All percentages are calculated as a percentage of the total OSDBU budget, except as noted. Agency OSDBUs provided the required training information and the training and travel costs. For FY 2020 agencies did not report any failures to comply with sections 637, 644, 657a, or 657f of the Act. Individual agency reports are summarized Table 1, below, and copies of agency actual reports are provided as Enclosures.

- In cooperation with the bureau small business specialist for the National Oceanicand Atmospheric Administration (NOAA), an operating unit of DOC, to host a virtual small business conference to educate small businesses on NOAA's mission and suggested methods to identify and pursue contract opportunities.
- In cooperation with the Director for the Asian American Pacific Islanders (AAPI) Initiative, housed in the Minority Business Development Agency (MBDA), an operating unit of DOC, participated in a virtual interagency small business conference to educate small businesses how to identify and pursue contract opportunities.

• Activities to train contract specialists:

Due to COVID-19 pandemic, the DOC annual workforce acquisition training conference, scheduled for May 2020 and which included Small Business Program workshops, was cancelled.

Finally, based on preliminary FPDS data, DOC is pleased to report that we successfully exceeded all FY 2020 prime contracting small business and socio-economic small business goals. The Department of the Treasury is committed to removing any barriers that impede the maximum utilization of small businesses in performing our requirements. The Treasury Office of Small Disadvantaged Business Utilization (OSDBU) cooperates in providing training to industry and Treasury's acquisition workforce. The OSDBU attends national conferences to explain how to do business with the Department of Treasury on an as needed basis.

For fiscal year 2020, the Department of the Treasury submits the following required report: 15 U.S. Code § 644 - Awards or contracts

- (16) shall submit, each fiscal year, to the Committee on Small Business of the House of Representatives and the Committee on Small Business and Entrepreneurship of the Senate a report describing—
- (A) the training provided by the Director under paragraph (13) in the most recently completed fiscal year (see paragraph 13below);
- (13) may provide training to small business concerns and contract specialists, except that such training may only be provided to the extent that the training does not interfere with the Director carrying out other responsibilities under this subsection;

The Treasury OSDBU sponsored the Large Business Prime Contractors' Training and SB Matchmaking Event @ George Mason University - 4 December 2019 (FY 2020). Approximately 150 persons were in attendance at no cost to Treasury OSDBU. Treasury OSDBU hosted three virtual Small Business Review System (SBRS) Training/Demonstrations. The training included the SBSs and the acquisition communities. Approximately 140 persons were in attendance. Treasury OSDBU did not incur any cost for these trainings.

(B) the percentage of the budget of the Director used for such training in the most recently completed fiscal year; and

The OSDBU training sessions outlined in (16)(A) were conducted in federal government space. The only cost involved was in preparation of the training materials, which were provided by Treasury's Printing and Graphics office, at no cost. Employees traveled via the metro to the training sites. Therefore, the training sessions represent 0% of Treasury OSDBU's total budget and 0% of Treasury's non-labor budget.

(C) the percentage of the budget of the Director used for travel in the most recently completed fiscal year; and

Treasury's OSDBU Director spent \$4,284 for out of town business travel in FY 2020 to participate in a variety of small business Conferences and Outreach events. **Treasury's OSDBU total budget of \$858,000 includes labor and non-labor dollars. The OSDBU Director used \$4,284 for travel expenses, which represent** 8.4% of the \$51,000 non-labor dollars.

Introduction

As required by Section (k)(16) of the Small Business Act at 15 United States Code (U.S.C.) § 644, the United States Department of Homeland Security (DHS), Office of Small and Disadvantaged Business Utilization (OSDBU), hereby submits this report describing the training activities provided to small business concerns and the DHS contracting community. In addition, the report includes percentage of the total OSDBU budget used for training and travel for the recently completed Fiscal Year (FY) 2020.

DHS is a recognized leader in small business contracting with a small business program that is well-respected in the federal government. By adopting many small business program initiatives and best practices that are unique to the federal government, DHS continued to pave the way to promote opportunities for small businesses to contribute their unique strengths to the DHS mission during FY 2020.

16(A)

In accordance with Section (k)(16)(A), the OSDBU set an aggressive schedule in FY 2020 to provide DHS-wide training on small business topics and socioeconomic federal contracting programs. As a result, the OSDBU created and facilitated seven learning webinars, which garnered over 1,500 distinct registrations from DHS acquisition professionals. The courses held in FY 2020 were:

- Service-Disabled Veteran-Owned Small Business Program
- Nonmanufacturer Rule
- DHS OSDBU Overview Responsibilities of the OSDBU
- 8(a) Contracting and DHS/SBA Partnership Agreement
- Subcontracting Plans and Mentor-ProtégéOverview
- HUBZone Program
- Women-Owned Small Business Program

The OSDBU also hosted a series virtual of workshops for the DHS Small Business Specialists (SBS) and the OSDBU staff with the purpose of discussing various small business contracting topics and best practices. The FY 2020 workshops included robust discussions on small business goal achievements, legislative updates and implementation from the Small Business Administration's General Counsel, the latest initiatives on strategic sourcing and category management, proposed solutions to small business challenges, and teambuilding. The OSDBU Executive Director, the Chief Procurement Officer, as well as the Deputy Chief Procurement Officer provided their thoughts on how the Department's success in supporting small businesses is recognized by leadership and is the direct result of the hard work and dedication of the DHS Small Business team, both at headquarters and throughout our components.

Since inception, the DHS has committed to implementing the federal public policy objective of including small businesses in our contracting program to the maximum extent practicable. Section 15(k)(10) of the Small Business Act (15 U.S.C. § 644(k)(10)) directs the OSDBU to make recommendations to contracting officers on the use of set-aside acquisition strategies to improve the likelihood of small business participation as prime contractors. In keeping with this directive, the OSDBU has ensured that our learning webinars and workshops include processes for providing opportunities for all types of small businesses to compete and win contracts in support of DHS' vital missions.

DHS's primary web platform for hosting these webinars, learning cafés, and workshops is through Adobe Connect, which one to two hours in length and recorded for on-demand viewing.

The OSDBU has a robust small business outreach program which includes hosting monthly Vendor Outreach Sessions (VOS) as well as attending major small business conferences sponsored by Government agencies, congressional members, and trade associations. The OSDBU meets one-on-one with hundreds of small businesses every year. Our discussions with small businesses focus on how to do business with DHS, to connect small businesses with the DHS contracting and program personnel, to support market research, to provide information about upcoming procurements, and to determine small business capabilities to fill DHS contracting requirements.

The DHS VOS program is known as a government-wide best practice. Vendor outreach sessions are a series of pre-arranged 15-minute appointments with small businesses and Small Business Specialists from DHS Components, plus several DHS large prime contractors. These sessions provide the small business community opportunities to discuss their capabilities and to learn more about doing business with DHS. Beginning in May 2020, due to COVID-19, the DHS OSDBU successfully transitioned VOS from long-standing, in-person activities, into a virtual presence. The current virtual format is applauded by industry and the SBS due to the flexibility with online meetings, less distraction from other attendees, and the ability for the SBS to navigate DHS.gov during their scheduled meetings. In addition, the DHS prime contractors that attend VOS as counselors also expressed appreciation for the ability to use their in-house virtual platform, which has maximized their interaction with small business attendees. In FY 2020, eight sessions were held with 426 vendors in attendance. After each VOS, attendees complete an evaluation, providing feedback on benefits from the VOS program. Overall evaluations resulted in a 96.57% average rating which represents a good to excellent rating for FY 2020.

FY 2020 Training and Travel Budget

(16)(B)

The DHS OSDBU training webinars and workshops outlined in (16)(A) were primarily conducted online due to the virtual environment in which we are operating, with a few in-person events taking place early in the fiscal year in federal government space. As such, there was no cost involved for the training webinars and workshops. Out of the total DHS OSDBU budget of \$1,784,500, \$0 (0%) was used for training.

(16)(C)

The DHS OSDBU spent \$6,000 for out of town business travel to participate in a variety of small business outreach events. Due to the pandemic, business travel for in-person outreach activities was paused and instead online conferences were attended. Out of the total DHS OSDBU budget of \$1,784,500, the \$6,000 used for travel represents 0.34% of the total budget.

Summary

During FY 2020, the DHS OSDBU relied on virtual delivery as the predominant mode of webinars, learning cafés, and workshops for the contracting community as well as for small business outreach activities. This enabled the OSDBU to reach a broader audience than was possible with in-person events while minimizing costs to the taxpayer. One hundred percent of the OSDBU's training events during FY 2020 allowed the option for virtual access, thus minimizing travel costs to the Government or participants.

The purpose of this letter is to transmit the Department of Labor's (DOL) Fiscal Year (FY) 2020 Training and Travel Report in accordance with paragraphs (16)(A), (16)(8), and (I6)(C) of Section I5(k) of the Small Business Act (15 U.S.C. 644).

During FY 2020, the Office of Small and Disadvantaged Business Utilization (OSDBU) provided training to hundreds of small businesses and to DOL's acquisition workforce. The OSDBU's quarterly vendor outreach training sessions provided small businesses with insight on how to network and market effectively to procurement decision-makers. These events also increased DOL acquisition workforce's awareness on how to compete contracting opportunities effectively among procurement-ready small businesses. During these training events, the OSDBU invited subject matter experts from the Small Business Administration (SBA), AbilityOne, General Services Administration (GSA), Historically Black Colleges and Universities (HBCUs), large and small businesses, contracting officers (CO), and DOL's program representatives to train on the following small business-related topics:

- Prime and subcontracting opportunities;
- 8(a) Partnership Agreement;
- Obtaining awards on the Multiple Award Schedules;
- Navigating the forecast tool;
- Employment for companies who hire people with disabilities;
- Increasing growth in the federal marketplace for HUBZone small businesses; and
- Simplifying the request for quotation process with ease for small and large businesses using the Reverse Auction platform.

The OSDBU is also committed to conducting regular training of acquisition personnel on issues, procedures, policies, and regulations impacting small businesses and has done so through DOL's Procurement Council meetings, emails, weekly trainings, and individual counseling/assistance. Moreover, DOL public website and LaborNet (intranet available to DOL employees) host a procurement page that provides acquisition personnel with continuous access to CO notices, informational training notices, acquisition policies, and webinars and training from outside sources such as SBA, GSA, Federal Acquisition Institute, and recently, the SBA's Small Business Innovation Research and Small Business Technology Transfer Programs.

Additionally, the OSDBU attended the following small business outreach events hosted by other organizations where small business concerns received individual training:

In FY2020 DOT continued its commitment to provide outreach, technical, and financial assistance to small business concerns and maximized the use of the Small Business Transportation Resource Centers (SBTRC). DOT's Office of Small and Disadvantaged Business Utilization (OSDBU) hosted several in person small business outreach sessions, prior to the start of the pandemic, for which the duties and responsibilities for the OSDBU Director are indicated in the Small Business Act.

Our office provided virtual acquisition training for Small Business Specialist (SBS), Program Officers and DOT acquisition officials on procurement rules and regulations impacting socioeconomic procurements. In accordance with Subsection (k) of section 15 of the Small Business Act (15 U.S.C. 644): I am writing to provide a report on the Department of State's Office of Small and Disadvantaged Business Utilization (OSDBU) training and travel for the Fiscal Year (FY) 2020. Please find below the Department's responses for the referenced sections of 15 U.S.C. 644.

(16)(A)

The Office of Small and Disadvantaged Business Utilization (OSDBU) provided an average of 1-2 monthly classroom trainings including one monthly webinar, hosted by the Small Business Administration (SBA), for the acquisition workforce, Program Managers and Foreign Service Officers. The training sessions had approximately 20-30 participants each. Each class focused primarily on educating contracting staff and program office personnel on an array of small business-related subjects including 8(a) Business Development Program, HUBZone Program, Service-Disabled Veteran-Owned Small Business Program, Woman-Owned Small Business Program; Joint Ventures and Subcontracts, Size Determination, Non-Manufacturer Rule, and Market Research. In addition to trainings provided by the OSDBU staff, OSDBU invited subject matter experts from SBA, National Aeronautics and Space Administration, and other organizations to speak on matters relevant to Subcontracting, Affiliations, Size Determination, Mandatory Sources, and the use of small business set asides in schedule contracts.

(16)(B)

Since the training outlined in (16)(A) was conducted in federal government space, the only cost involved was preparation of the training materials, which was included in the OSDBU total FY 2020 reproduction expense of \$3,961.

(16)(C)

The State Department OSDBU spent \$13,138 for out of town business travel in FY 2020 to participate in a variety of small business outreach events. Out of the total OSDBU budget of \$237,900, the \$13,138 used for travel represents 5.5% of the total budget.

Annual Report Fiscal Year 2020



As required by section 15(k)(16) of the Small Business Act (15 U.S.C. § 644(k)(16)), the Department of Veterans Affairs (VA) Office of Small and Disadvantaged Business Utilization (OSDBU) submits this report describing the training activities conducted for small business concerns and for contracting personnel. The report also includes data on the portion expended for this training representing a percentage of the total OSDBU budget, as well as the percentage of the OSDBU budget expended for travel. Finally, this report describes actions OSDBU takes to promote the Department's compliance with Small Business Act and Veterans First Contracting Program requirements.

Consistent with the priorities established by the law authorizing VA's Veterans First Contracting Program (38 U.S.C. §§ 8127-28), OSDBU and other VA organizations emphasize events targeting Service-Disabled Veteran-Owned Small Businesses (SDVOSB) and Veteran-Owned Small Businesses (VOSB). Small businesses holding other socioeconomic statuses also benefit from such training sessions, particularly if they seek dual certification as verified SDVOSBs or VOSBs in addition to their existing socioeconomic statuses. OSDBU participates in a range of small business outreach activities, which often include training presentations. These events are conducted by other VA organizations; Federal, state or local agencies; trade associations; and Veterans Service Organizations. OSDBU prioritizes its participation decisions to align with VA's Veterans First requirement.

OSDBU conducts limited training for small businesses and contracting personnel during its signature event, the National Veterans Small Business Engagement (NVSBE). Instead of emphasizing training, the goal of NVSBE is to connect small businesses with VA contracting and program personnel (procurement decision makers, or PDM), to support market research, provide information about upcoming procurements and determine small business capabilities to fill VA contracting requirements. SDVOSBs and VOSBs find it advantageous to complete needed training before attending NVSBE so they arrive as procurement-ready firms, able to take full advantage of opportunities to market themselves to PDMs. Because OSDBU receives extensive support from other VA offices, as well as other Federal agencies, NVSBE offers unprecedented matchmaking and direct access to PDMs. For the training portion of this report, OSDBU has included learning sessions conducted by OSDBU staff as part of NVSBE. Travel costs to NVSBE are included in the percentage of OSDBU's budget expended on travel since the statutory mandate for this report covers all travel and not just travel associated with a training activity.

Regarding training for contracting personnel, OSDBU training addresses processes for which OSDBU is responsible. For example, section 15(k)(10) of the Small Business Act (15 U.S.C. § 644(k)(10)) directs OSDBU to make recommendations to contracting officers on the use of set-aside acquisition strategies to improve the likelihood of small business participation as prime contractors. OSDBU provides recommendations for alternative approaches to contracting officers in response to

proposed acquisition strategy submissions. OSDBU conducts training on this process to clarify expectations and avoid unnecessary delays.

In addition to in-person training at small business outreach events, OSDBU's primary training format uses interactive webinars, recorded for on-demand viewing. Webinars are typically 30 to 60 minutes long and are accessed over the internet using a standard computer browser. Individuals use a web-based platform to register for webinars and view the training material used during the session.

This training format provides long-term value to both VA and participants. Presentations can be accessed on-demand after the training event has ended. Participants can review the session multiple times and revisit the material for reference and apply the information, as needed.

Fiscal Year (FY) 2020

VA verification of SDVOSBs and VOSBs is a prerequisite for participation in the Veterans First Contracting Program. This program affords verified firms owned and controlled by Veterans the opportunity to compete for VA set-aside procurement opportunities. OSDBU hosts recurring training sessions to inform SDVOSBs and VOSBs about verification and provide assistance before, during and after the application process. Verification training focused on the following topics:

- Veterans First Contracting Program;
- Submitting for Verification Two-step process and required documents;
- Pre-Application Webinar;
- Preparing for Reverification Webinar;
- How to Stay Verified Webinar;
- Veterans Engagement Management System Portal Usage; and
- Department of Defense Self-service Logon and ID.me Account Usage.

To assist verified SDVOSBs and VOSBs to compete for VA procurement opportunities, OSDBU offers a procurement-readiness training program. The program included the following modules:

- Procurement Readiness Overview:
- Introduction to VA OSDBU;
- Doing Business with VA;
- Building an Effective Capabilities Statement;
- How to Prepare for Attendance at Direct Access Events; and
- Framework for Success-Focused Business Model Training, which includes:
 - Introduction to the Framework for Success Business Model; and
 - Risk Mitigation Solutions to help minimize risks for both small businesses and the Federal Government.

Virtual training sessions were offered to small businesses prior to the 2019 NVSBE during the first quarter of FY 2020. Over 1,294 SDVOSBs/VOSBs and 448 small businesses attended this event, held in Nashville, Tennessee, on December 10-11, 2019. These sessions were hosted by VA organizations and industry leaders with OSDBU's assistance. Examples included the following:

- How to Obtain a National Acquisition Center Federal Supply Schedule Contract;
- How to Produce a National Acquisition Center Federal Supply Schedule Proposal; and
- Taking the Leap from Sub to Prime.

Additionally, the following virtual training modules were purposefully offered to help prepare potential attendees to take full advantage of the matchmaking opportunities at the event:

- Building an Effective Capabilities Statement;
- Characteristics of Procurement Readiness;
- Doing Business with VA;
- Overview of the VA SDVOSB/VOSB Verification and Reverification Processes; and
- Responding to Requests for Information and Sources Sought.

In FY 2020, OSDBU continued its efforts to increase the representation of women Veteran entrepreneurs in the Federal market, with several efforts under the Women Veteran-Owned Small Business (WVOSB) Initiative. The initiative, which started in FY 2019 in collaboration with other Federal agencies and strategic partners, sought to expand economic, procurement and learning opportunities for Women-Owned SDVOSBs/VOSBs through a focused program. The FY 2020 training sessions included:

- Your Business Journey Documenting and showcasing some of VA'smost successful WVOSBs;
- Collaboration with the Texas and Virginia State Veterans agencies to further awareness and opportunities for WVOSBs, with 2,678 attendees and more than 100 women mentored on starting a business;
- Engagements with the Department of Homeland Security, Export-Import Bank and Google, which reached 100 WVOSBs;
- Veterans Experience Live (VetXL) event with the Deputy Secretary of Veterans Affairs, encouraging Women Veterans to pursue entrepreneurship as a transition option with over 300,000 views of the sessions; and
- A reception during the 2019 NVSBE recognizing the 30 WVOSBs thatgraduated from the first-year WVOSB Initiative cohort.

Overall, in FY 2020, OSDBU trained approximately 5,100 participants through all webinars. Based on feedback, this virtual format provides affordability for SDVOSB and VOSB participants by delivering time-efficient, cost-effective training. Accordingly, VA staff optimized service to our SDVOSB and VOSB stakeholders without incurring travel

costs. Virtual delivery also allowed participants to avoid the risks associated with travel during the Coronavirus Disease 2019 (COVID-19) pandemic.

Small Business Act Compliance (Section 15(k)(16)(D))

In the National Defense Authorization Act for FY 2017 (P.L. 114-328), Congress amended the requirements for this report to add a new element, describing each reporting agency's compliance with sections 8, 15, 31 and 36 of the Small Business Act. In general, these provisions require contracting officers to consider small disadvantaged businesses and WOSBs (sections 8(a) and 8(m), respectively), qualified HUBZone small businesses (section 31), SDVOSBs (section 36) and all small businesses (sections 15(a) and 15(j)) for set-aside opportunities. With respect to SDVOSBs, VA may award contracts only to SDVOSBs whose ownership and control have been verified under its Veterans First Contracting Program and may not award set-asides or sole-source contracts to unverified firms that are allowed to participate in the Government-wide program under section 36.

In effect, the Veterans First Contracting Program has displaced the Government-wide SDVOSB program at VA, but also provided new VA-specific authority for set-asides and sole-source awards to all VOSBs. The law also mandates a procurement hierarchy, requiring SDVOSB and VOSB awards to be considered first and second, prior to consideration of other small business program authorities. In compliance with those mandates, this report addresses VA's compliance with its own Department-specific program rather than the Government-wide program.

To aid compliance with these requirements, section 15(k)(10) of the Small Business Act charges OSDBU with making recommendations to contracting officers on the use of the various set-aside authorities. VA carries out this requirement through review of VA Form 2268, which is used to obtain concurrence on a contracting officer's proposed acquisition strategy and the supporting market research and other documentation. OSDBU provides an independent review of these materials to assess the adequacy of market research and the rationale whether to set-aside the action. If OSDBU recommends an alternative strategy (such as use of a set-aside where a

contracting officer originally did not plan to do so), and the contracting officer opts not to implement the OSDBU recommendation, OSDBU policy requires the cognizant program office and Head of Contracting Activity to review and concur with the contracting officer's decision. Form 2268 retains this documentation for the contract file, as required by section 15(k)(10).

VA Form 2268 also provides documentation for the statutory mandate to set-aside transactions below the Simplified Acquisition Threshold, contained in section 15(j) of the Small Business Act. The law provides that such transactions are presumptively set-aside unless the contracting officer documents there is not a reasonable expectation of two or more competitive offers. Because of the volume of transactions at this level, OSDBU has delegated review of VA Form 2268 to the small business liaisons (SBL) in the contracting activities, to ensure more effective coverage. OSDBU regularly consults with the SBLs to provide guidance. In addition, the Secretary of Veterans Affairs established small business participation goals for these transactions in FY2020.

OSDBU is unaware of any deliberate non-compliance with these set-aside requirements. The assessment of market research and the conclusion whether there is a reasonable expectation of two or more offers is a judgment call and often can lead to reasonable reviewers reaching different conclusions. The VA Form 2268 review process seeks to ensure that multiple reviewers agree with the conclusions made and reduces the likelihood that any single person would be able to to make an arbitrary decision. In addition, VA's statutory set-aside mandate for the Veterans First Contracting Program is reviewable both through bid protests as well as judicial processes.

<u>Summary</u>

During FY 2020, OSDBU relied on virtual delivery of webinars as the predominant training modality for small businesses and contracting personnel. OSDBU reached a broader audience than was possible through face-to-face sessions while minimizing costs to the taxpayer. Virtual events also provided a safe means to continue the OSDBU mission during the COVID-19 pandemic.

Nearly all of OSDBU's total training events during FY 2020 were provided virtually, without travel costs to the Government or participants. The cost to provide training to small businesses and contracting personnel remained well below one-tenth of 1% of total OSDBU obligations. As a result of OSDBU's use of the virtual training format, travel costs were less than one-fifth of 1% of OSDBU's total budget.

(16)(a). Due to COVID-19, travel for training was restrained across DoD. OSD's annual Small Business Training Week (SBTW) was conducted virtually. The virtual SBTW environment allowed OSD, in collaboration with the Small Business Administration and other Federal Agencies, to reach a greater number of participants than in recent years with over 1,000 members of the Federal workforce attending. A total of 20 additional outreach and training events were conducted virtually. The focus of the trainings was both to ensure that small businesses were able to continue to operate during the COVID-19 pandemic and that DoD met it's 22.05% statutory requirement. Topics at these events included: Congressional updates and policy changes; cybersecurity; an emphasis on Personal Protection Equipment (PPE) availability; the Paycheck Protection Program process and ensuring small business resiliency through the progress payment initiative; Fed Mall Program hosted by the Defense Logistics Agency (DLA); and authorizations to operate during COVID-19.

(16)(b). Out of the total DoD OSBP \$3.3 million operating budget \$200,069 was used for training the workforce, representing 6.67% of the total budget.

(16)(c). DoD OSBP also participated in a number of events during FY20 to train both small businesses and small business professionals within the government. These trainings focused on continuing our efforts to improve the small business community's knowledge of, and capability to, successfully navigate and compete for government contracts. Given the impact of COVID-19, the Director only traveled to take part in one event in FY20 (listed below) for a total cost of \$1,569.29; the remaining events were either held locally or conducted virtually. This cost represents 0.05% of the total DoD OSBP \$3.3 million operating budget. A detailed outline of the travel is charted below.

Introduction

Fiscal Year (FY) 2020 preliminary data indicate the U.S. Agency for International Development (USAID) obligated 14.90 percent of its contract dollars to U.S. small businesses, which exceeded the Agency's goal of 12 percent. This equates to \$923 million and marks the highest percentage and aggregate amount of contract-dollar obligations the Agency has ever awarded to U.S. small businesses within a single fiscal year.

Training Provided

USAID's Office of Small and Disadvantaged Business Utilization (OSDBU) conducted five training sessions to educate 104 program and contracting officials on U.S. small business programs. The training sessions took place in Indonesia, Thailand, Nepal, and Germany. The curriculum included USAID's internal small business goaling program to increase the utilization of small businesses world-wide, discussion which highlighted the impact of U.S. small business on the U.S. economy, statutory and regulatory requirements, market research, subcontracting, and contract bundling.

In addition to training, the OSDBU Director conducted briefings for the Missions' senior leadership. The briefings also discuss to identify opportunities to increase engagement and inclusion of small businesses in USAID procurements. Training sessions, coupled with the senior- and working-level briefings, virtual and in-person have broadened small business participation awareness across the Agency.

As a result of the COVID pandemic, the remaining scheduled Washington DC training sessions were cancelled.

Training Expenses

In FY 2020, the OSDBU utilized the services of an existing small business contractor with professional instructors to provide the training sessions. The contractor agreed to a 6-month no-cost extension due to the lapse of appropriations in FY 2019. As a result, the Agency did not incur any fixed costs from the contractor in FY 2020.

The Agency's contractual expenditures for the training sessions were \$16,942 inclusive of travel-related costs of \$16,942 for the instructor's costs. OSDBU's FY 2019 Operational Expenses (OE) budget was \$350,000. Therefore, OSDBU used 4.8 percent of its FY 2020 OE budget to provide training to small businesses.

At the end of FY 2019, OSDBU's contractual expenditures for similar training sessions were approximately \$87,457.31, so the office decreased its training expenses for FY 2020 by approximately 80 percent from the prior-year period.

Training-Related Travel Expenses for the OSDBU Director

In FY 2020, OSDBU's Director incurred \$14,783 in travel expenses to carry out the Agency's requirements for outreach to small businesses and coordinate with senior USAID officials stationed in Indonesia, Thailand, Nepal, and Germany. Travel expenses equate to 4.2 percent of OSDBU's FY 2020 OE budget.

Such efforts included developing agency small business training, participating in small business outreach events and educational campaigns, briefing the agency's senior leaders on small business-related matters, educating business owners on navigating the Federal marketplace, conducting daily counseling sessions, and providing technical assistance to acquisition staff by supporting market research efforts and explaining the mechanics of set-asides.

Specific examples of such training to acquisition staff and the business community include the following activities listed below.

- Assisted with the development of small business training offered to acquisition staff at the agency's onsite training center and web-based training portal. The course covered topics such as the importance of small businesses, relevant laws, market research, and the benefits of contracting with small businesses.
- Expanded its outreach efforts to by participating in virtual events that educated companies on how to navigate the agency's contracting landscape, explained the services offered by the Small Business Program and available resources, and discussed how to identify prime and subcontract opportunities.
- Briefed the NRC Commission on its increased engagement with acquisition staff during the market research phase of the procurement process, provided an update on the Small Business Administration's Scorecard performance measures, highlighted progress towards meeting agency small business prime contract goals, and discussed its strategies toachieve futuresuccess.
- Participated in educational campaigns supporting Federal small business programs and initiatives, including the Veterans Institute for Procurement training program, which is sponsored by the Small Business Administration.

- Maintained daily counseling sessions with senior business executives to explain the resources available under the agency's web-based Small Business Toolbox and how to effectively use the tools to foster the business development needs of Federal contractors.
- Provided technical assistance to acquisition staff on how to effectively
 evaluate small business marketplace capability, available contracting vehicles
 and streamlined acquisition strategies, and the mechanics of conducting setasides under the various rules associated with the Federal portfolio of small
 business programs.

Section 15(k)16(B) - Percentage of Budget Used for Training

While there are costs associated with the training and resources mentioned above in Section 15(k)16(A), the costs were incurred by other NRC offices, Federal agencies, and organizations. As a result, the Small Business Program did not fund any training costs from its budget (other than the time and effort expended by Small Business Program staff). Therefore, there are no direct costs attributed to the Small Business Program's budget.

Section 15(k)16(C) - Percentage of Budget Used for Travel

The Small Business Program spent \$ 3,585.00.1 for out of town business travel to participate in two small business outreach events (National Veterans Small Business Conference and National 8(a) Association Conference). Out of the total Small Business Program budget of \$127,000.00, the \$3,585.00 used for travel represents approximately 2.8 percent of the Small Business Program budget, which was severely impacted by the COVID-19 pandemic's restrictions on travel and gatherings.

¹Costs associated with airfare not included as airfare is funded from a central agency account and not through the Small Business Program's budget. In addition, this amount does not capture travel costs associated with contractor support for out of town outreach events.

- 2. Below is the National Science Foundation (NSF) input which corresponds to the requested information in subparagraphs (A), (B) and (C) listed above.
- (A) In FY 2020, NSF continued to leverage small business trainings provided by various other federal agencies. The NSF small business office and the NSF acquisition community was informed of small business training sessions that were available throughout the year from numerous federal agencies and associations. Such trainings included the SBA First Wednesday Virtual Learning 2020 series, DOD Mid Atlantic Regional Council (MARC), and the Small Business Socio-economic program utilization training sessions. The NSF Small Business Office participated in the virtual Government Procurement conference (GPC). Numerous one-on-one matchmaking sessions was held; publicizing, educating, and training small businesses on "how to" do business with NSF. Additionally,

NSF small business office holds weekly one-on-one meetings with small businesses from around the country, to educate and assist them in understanding acquisition opportunities at NSF.

- (B) There were minimum direct costs associated for training in FY20 since NSF leveraged other federal agency trainings as discussed in subparagraph (A) above. The budget for the NSF OSDBU for FY20 was \$50,000. Consequently, approximately 1% of the NSF total OSDBU budget was used for training in FY 2020.
- (C) Due to the COVID-19 pandemic, for FY2020, NSF OSDBU did not partake in any local and out of town business travel to participate in inperson training events. All outreach and training sessions were held in a virtual environment. Out of the total NSF OSDBU budget of \$50,000, the OSDBU used 0% of the total budget for travelexpenses.
