

# Checklist for Starting a Business in North Dakota

This checklist provides information on general requirements that need to be addressed for most new businesses. These agencies provide the necessary forms and instructions on how to submit them. This checklist is not a comprehensive guide; other specific requirements may also apply.

  - Trade Name Registration – your first contact should be with the North Dakota Secretary of State's office to determine if your chosen business name is available.
