The Department of Homeland Security (DHS) is honored to again receive high marks from the Small Business Administration (SBA) for the significant accomplishments made in our small business program. Since SBA started the letter grade Scorecard format in FY 2009, DHS has received a grade of "A" or "A+" eight years in a row, the largest federal agency to have such a track record. In FY 2016, about 16,000 companies representing all 50 states, Washington DC, and five territories had DHS prime contracts.
