## **SBA Disaster Loans Available Following Secretary of Agriculture Disaster Declaration in Tennessee**

**ATLANTA** - The U.S. Small Business Administration announces today that federal economic injury disaster loans are available to small businesses, small agricultural cooperatives and most private non-profit organizations of all sizes located in the State of Tennessee as a result of excessive rain, extensive flooding, and cooler than normal temperatures that began on September 1, 2009.

These loans are available in the following counties: Bledsoe, Bradley, Cannon, Chester, Clay, Crockett, Cumberland, Davidson, DeKalb, Dyer, Fayette, Fentress, Hamilton, Hardeman, Hardin, Haywood, Henderson, Jackson, Lauderdale, Loudon, Macon, Madison, Marion, McMinn, McNairy, Meigs, Monroe, Morgan, Polk, Putnam, Rhea, Roane, Rutherford, Sequatchie, Shelby, Smith, Sumner, Tipton, Trousdale, Van Buren, White, and Wilson in Tennessee.

“When the Secretary of Agriculture issues a disaster declaration to help farmers recover from damages and losses to crops, the Small Business Administration issues a declaration to assist eligible entities affected by the same disaster,” said Frank Skaggs, Director of SBA’s Field Operations Center East.

Under this declaration, the SBA’s Economic Injury Disaster Loan program is available to eligible farm-related and nonfarm-related entities that suffered financial losses as a direct result of this disaster. Farmers and ranchers are not eligible to apply to SBA.

Victims may qualify for loans up to \$2 million. These loans are available at a 4 percent interest rate with loan terms up to 30 years. The SBA determines eligibility based on the size of the applicant, type of activity and its financial resources. Loan amounts and terms are set by the SBA and are based on each applicant’s financial condition. Under this disaster declaration, the SBA cannot provide loans to agricultural producers.
