

## **INSTRUCTIONS ON HOW TO APPLY FOR APPROVAL AS A THIRD PARTY CERTIFIER**

On October 7, 2010, the SBA issued regulations at 13 C.F.R. part 127 implementing the Women-Owned Small Business (WOSB) Program, as authorized by section 811 of the Small Business Reauthorization Act of 2000, Public Law 106-554 (15 U.S.C. 637(m)). This regulation, effective February 4, 2011, authorizes Federal contracting officers to restrict competition to eligible WOSBs or Economically Disadvantaged WOSBs (EDWOSBs) for Federal contracts in certain industries. As part of this implementation, SBA allows, per statute, WOSBs or EDWOSBs to be certified by “national certifying entities,” also referred to as Third Party Certifiers. The purpose of these instructions is to identify the process by which SBA will approve such national certifying entities as Third Party Certifiers for the WOSB Program and to establish the terms and conditions by which the Third Party Certifier will accept, review, examine, and decline applications for WOSB and EDWOSB certifications and, if applicable, withdraw certifications pursuant to SBA regulations at 13 C.F.R. part 127.

These instructions apply to entities seeking status as a “Third Party Certifier” pursuant to SBA regulations at 13 C.F.R. part 127, governing the WOSB Program. They establish the acceptable requirements for the format and content of the Third Party Certifier Application upon which SBA will base its decision to approve or decline an entity’s status as an SBA approved “Third Party Certifier.”

A National Certifying Entity seeking approval as a Third Party Certifier must submit one copy of its Third Party Certifier Application via UPS or Federal Express directly to the United States Small Business Administration, Attn: Diane Heal, Assistant Director, Office of Contract Assistance, at 409 Third Street SW, Washington DC 20416. Applications will be accepted only twice a year and must be post-marked by the end date of the applicable timeframe: (1) between February 4 and March 1, 2011 and (2) between September 1 and October 1, 2011.

The Third Party Certifier Application shall include the following: (1) a cover page that states the name, address, point of contact, phone number, fax number, email, and website of the submitter; (2) a completed, signed and dated Third Party Certifier Certification Form, which is attached, and (3) the documentation identified in the Third Party Certifier Certification form, which shall be labeled according to the following categories: General Requirements, The Certification Process, and Supporting Documentation. With regard to the Third Party Certifier Certification Form, the proposed Third Party Certifier must truthfully and accurately check all of the boxes and have an authorized officer of the Third Party Certifier sign and date the certification.

If any of the information identified below is missing from the Third Party Certifier Application, SBA will request additional information from the entity and provide the proposed Third Party Certifier with 10 business days from the date of their receipt of SBA’s request to provide a response. If SBA does not receive a complete Third Party Certifier Application within 10 business days, it will return the entire package. Once a complete package has been submitted,

SBA will review and determine if the information submitted warrants approval as a Third Party Certifier. The SBA will notify each entity that submits a Third Party Certifier Application of its decision in writing.

If SBA approves the Third Party Certifier Application, the entity will be notified by SBA and SBA will post the Third Party Certifier's contact information on its website at [www.sba.gov/WOSB](http://www.sba.gov/WOSB).

If SBA believes that an entity has failed to provide sufficient information to be approved as a Third Party Certifier, SBA will explain its reasons for the denial in writing. Any entity denied status as a Third Party Certifier may ask for reconsideration within 15 calendar days of the receipt of the denial letter to the Associate Administrator for Government Contracting/Business Development, or as provided for in the denial letter.

An entity may apply again during the timeframes specified above and must include in any subsequent Third Party Certifier Application SBA's denial letter and an explanation as to how the proposed Third Party Certifier has overcome the reasons for denial.

**THIRD PARTY CERTIFIER CERTIFICATION FORM**

Please read the following certification form statements carefully. The Federal government relies on the information in this form and any documents or supplemental information submitted to determine whether the entity should be approved as a Third Party Certifier under the WOSB Program. The definitions for the terms used in this certification are set forth in the Small Business Act, SBA regulations (13 C.F.R. Part 127), and also any statutory and regulatory provisions referenced in those authorities. In addition, please note that the U.S. Small Business Administration (SBA) may request further clarification or supporting documentation in order to assist in the verification of any of the information provided and that each person signing this certification may be prosecuted if they have provided false information. Any action taken with respect to this certification does not affect the Government’s right to pursue criminal, civil or administrative remedies for incorrect, incomplete, false or misleading information given, even if correct information has been included in other materials submitted to SBA.

***The undersigned authorized official has reviewed, verified and certifies that (all boxes must be checked):***

General Requirements

The proposed Third Party Certifier is a nonprofit certifying entity and has provided, in support of this Certification, proof of its nonprofit status by one of the following means: (a) Proof that the Internal Revenue Service currently recognizes the entity as an organization to which contributions are tax deductible under section 501(c)(3) of the Internal Revenue Code; (b) A statement from a State taxing body or the State attorney general certifying that: (i) The organization is a nonprofit organization operating within the State; and (ii) No part of its net earnings may lawfully benefit any private shareholder or individual; (c) A certified copy of the entity's certificate of incorporation or similar document if it clearly establishes the nonprofit status of the entity; or (d) Any item described in paragraphs (a) through (c) if that item applies to a State or national parent organization, together with a statement by the State or parent organization that the entity is a local nonprofit affiliate.

The proposed Third Party Certifier meets the following requirements, which establish its capability to process certification applications from business concerns on a national basis:

- a. A minimum of two years of recent experience (i.e., measured from the date of submission of the Third Party Certifier Application) certifying businesses at the Federal or State level for compliance with small, disadvantaged, veteran-owned or women-owned business development or contracting program requirements. Attached is all relevant information showing that it meets this requirement,

including when the entity started certifying companies, how many it has certified, and the types of certifications issued.

b. Adequate staff with recent experience (i.e., within 2 years of the date of submission of the Third Party Application) in conducting eligibility reviews of businesses at the Federal or State level for compliance with small, disadvantaged, veteran-owned or women-owned business development or contracting program requirements. Attached is a listing of the staff, by title, job description, and each staff person's resume, that will be conducting such eligibility reviews.

c. A written policy on training its staff on a regular basis, including training on certification procedures, and how it will address changes to the SBA's regulations. Attached is the written policy on training.

The proposed Third Party Certifier will advise the Applicant (the small business that submits an application to an approved Third Party Certifier for certification as a WOSB or EDWOSB), in writing and prior to beginning the certification process, that under SBA regulations, the Applicant may obtain WOSB or EDWOSB certification, at no cost, through self-certification. Attached is the form of document to be used to advise the Applicant of its right to obtain non-cost self-certification under the WOSB program.

The proposed Third Party Certifier has a written policy of rendering fair and impartial EDWOSB or WOSB certification determinations. The policy states that it will be free of any conflict of interest with the Applicant and contains procedures for finding and addressing potential conflicts of interest. Specifically, the policy states that a conflict of interest occurs when a person or entity has an interest which makes it unable to render impartial assistance or advice, or the person's or entity's objectivity in performing is impaired, such as if the proposed Third Party Certifier or individual reviewing the certification application has a direct or indirect ownership or control or other financial interest in the Applicant being reviewed. The procedures require the Third Party Certifiers to conduct due diligence in determining if a conflict of interest exists. Attached is the written policy.

The proposed Third Party Certifier's past performance shows that it has rendered fair and impartial determinations, including but not limited to, having no legal proceedings in which the entity has been found to have rendered an unfair or partial determination. There is nothing in its past performance that would tend to show evidence of rendering unfair or partial determinations.

The proposed Third Party Certifier has a written policy which permits any concern or any individual on behalf of a business the right to apply for WOSB or EDWOSB certification whether or not there is an appearance of eligibility. Attached is the written policy.

The proposed Third Party Certifier has a written policy of not declining to accept or approve an application for EDWOSB or WOSB certification on the basis of race, color, national origin, religion, age, disability, sexual orientation, or marital or family status. Attached is this written policy.

The proposed Third Party Certifier will provide SBA with a monthly report by the fifth of each month identifying the previous month's activity, including the following information: the number of WOSB applications received, the number of EDWOSBs applications received, the total number of applications approved, the total number of applications declined for each type of application and the total number of firms whose status has changed (e.g., ineligible or de-certified); any issues or concerns of fraud, waste and abuse; a statement as to whether there have been any changes in policy regarding the certification procedures, and, if there have been any changes, the certifying entity must explain those changes. The report must also identify all of the WOSBs and EDWOSBs which were certified by the Third Party Certifier name, address, contact name and telephone number, as well as whether the firm was certified as a WOSB or EDWOSB.

The proposed Third Party Certifier will safeguard the confidential information provided by SBA or the Applicant, and has not had a breach of such confidential information within the last three years. The proposed Third Party Certifier must sign a confidentiality agreement with each Applicant stating that it will not release to anyone except the Applicant (and, as appropriate in the performance of their official functions, SBA and other government officials) any confidential information received from the Applicant. Attached is the policy on confidential information and the confidentiality agreement.

The proposed Third Party Certifier will not refer to SBA's approval of the entity as a Third Party Certifier in commercial advertising in such a manner as to state or imply that the service provided is endorsed or preferred by the Federal Government or is considered by the Government to be superior to other products or services, including self-certification, or that this Third Party Certification can be used for anything other than the WOSB Program.

The proposed Third Party Certifier may not use the SBA logo, including using the SBA logo as part of any hyper-link leading to any of its own web pages or sites. It may link to SBA.gov as long as the descriptive words associated with the link to SBA.gov are accurate and not misleading and do not misrepresent any relationship between the linking site and SBA.gov. Advance permission is not required in order to link to SBA.gov provided these conditions are followed.

### The Certification Process

The proposed Third Party Certifier has a written, clear and objective certification process for accepting, reviewing, and examining an application for WOSB or EDWOSB certification, as well as for declining and withdrawing WOSB and EDWOSB certifications. Attached is the written certification process evidencing each of the requirements below.

The proposed Third Party Certifier's certification process requires the Applicant to provide the Third Party Certifier with sufficient information to evaluate whether the Applicant has satisfied of all of the requirements set forth in 13 C.F.R. part 127.

The proposed Third Party Certifier's certification process requires the Third Party Certifier to examine an Applicant's request for WOSB or EDWOSB certification based on the requirements set forth in 13 C.F.R. part 127 and will only approve an Applicant's request if the Applicant has satisfied all such requirements.

The proposed Third Party Certifier's certification process requires the Applicant to submit information demonstrating, in accordance with 13 C.F.R. part 127, whether the concern is:

- a. A small business concern under SBA's size standards for its primary industry classification;
- b. At least 51 percent owned and controlled by one or more women who are United States citizens; and
- c. In the case of a concern applying for EDWOSB certification, at least 51 percent owned and controlled by one or more women who are United States citizens and economically disadvantaged.

The proposed Third Party Certifier's certification process requires, at a minimum, that each Applicant submit a copy of the following documents (signed, as applicable):

- a. Birth certificates, Naturalization papers, or unexpired passports for owners who are women;
- b. Copy of the joint venture agreement with any third party, if applicable;
- c. For limited liability companies: (i) Articles of organization (also referred to as certificate of organization or articles of formation) and any amendments; and (ii) Operating or member agreement, and any amendments;
- d. For corporations: (i) Articles of incorporation and any amendments; (ii) By-laws and any amendments; (iii) All issued stock certificates, including the front and back copies, signed in accord with the by-laws; (iv) Stock ledger; and (v) Shareholder or voting agreements, if any;
- e. For partnerships, the partnership agreement and any amendments;
- f. For sole proprietorships (and corporations, limited liability companies and partnerships if applicable), the assumed/fictitious name certificate(s);
- g. Information to verify the business is small for its primary NAICS (see 13 C.F.R. part 121); AND
- h. For EDWOSBs, in addition to the above, SBA Form 413, Personal Financial Statement, available to the public at <http://www.sba.gov/tools/Forms/index.html>, for each woman claiming economic disadvantage; the three most recent personal income tax returns (including all schedules and W-2 forms) for the women claiming economic disadvantage and their spouses, unless the individual and their spouse are legally separated.

The proposed Third Party Certifier's certification process requires the Applicant to pre-register on the Central Contractor Registration (CCR) at <https://www.bpn.gov/ccr/default.aspx>.

The proposed Third Party Certifier's certification process requires the Third Party Certifier to notify the Applicant that it must represent its status in the Online Representations and

Certifications Application at <https://orca.bpn.gov> after registering in CCR and submitting the required document to the repository,

The proposed Third Party Certifier's certification process requires the Third Party Certifier to maintain the right, in its discretion, to request clarification of information contained in the WOSB or EDWOSB application at any time in the certification process.

The proposed Third Party Certifier's certification process requires the Third Party Certifier to ensure that all certified WOSBs and EDWOSBs meet the eligibility criteria of the program even if there are any subsequent changes in statute or regulations.

The proposed Third Party Certifier's certification process requires the Applicant to promptly inform the Third Party Certifier of any changed circumstances that could adversely affect the Applicant's eligibility for the program (including a change in the WOSB or EDWOSB, as well as a change in SBA regulation) and requires the Third Party Certifier to consider any changed circumstances for an Applicant occurring subsequent to application and which adversely affect eligibility. The certification process must show that the Third Party Certifier will consider whether such changed circumstances are grounds to decline the Applicant's application.

The proposed Third Party Certifier's certification process requires the decision to approve or decline WOSB or EDWOSB certification to be in writing and state the specific reasons for decline.

The proposed Third Party Certifier's certification process requires decline of an application for WOSB or EDWOSB Certification if:

- a. There are any deficiencies from one or more certification criteria identified in 13 C.F.R. part 127, and the Applicant fails to address the deficiencies in a timely and acceptable manner.
- b. The Applicant unduly delays, limits, or denies the Third Party Certifier access to the establishment, products, or records needed to verify compliance with certification criteria.
- c. The Third Party Certifier discovers that the Applicant, or any of its officers or employees, engages in any improper actions in connection with the

certification process, such as providing false information to the Third Party Certifier or SBA.

- d. The Applicant is currently debarred or suspended from Federal Government Contracting.

The proposed Third Party Certifier's certification process requires the Third Party Certifier to maintain a written quality assurance program identifying the review/audit process, its documentation, methods of internal review, identification of staff position(s) performing the reviews, and at least annual reviews. Attached is the written quality assurance program.

Attached is a sample WOSB certification. All of the proposed Third Party Certifier's WOSB certifications will meet the following requirements:

- a. Will be based on circumstances existing on the date of application or any subsequent certification (i.e. a re-certification) and identify such date on the certification
- b. Will state on the certification that "This WOSB Certification will automatically expire after one year from the date identified on the certification letter." The Third Party Certifier must make a new certification determination on all firms on an annual basis in order for the WOSB or EDWOSB to remain certified.
- c. Will state on the certification that "This WOSB Certification will be effective for one year from the date identified on the certification letter unless there is a change in SBA's regulation that makes the WOSB or EDWOSB ineligible or there is a change in the WOSB or EDWOSB that makes the WOSB or EDWOSB ineligible. If either change occurs, this WOSB Certification is immediately invalid."
- d. Will require the WOSB or EDWOSB to promptly inform the Third Party Certifier and SBA of any changed circumstances, including a change in SBA's regulation or a change in the WOSB or EDWOSB, that could make the WOSB or EDWOSB ineligible for the WOSB program or of any intended changes that may affect certification in the future. The certification process must show that the Third Party Certifier will consider whether such changed circumstances are grounds for withdrawal.
- e. Will provide that failure to inform the Third Party Certifier of any such changed circumstances constitutes good cause for which the certification may be withdrawn or grounds for decline of the application for certification.

- f. Will be dated and state that: “The identified small business is an eligible WOSB or EDWOSB for the WOSB Program, as set forth in 13 C.F.R. part 127 and has been certified as such by an SBA approved Third Party Certifier pursuant to the Third Party Certifier Agreement, dated \_\_\_\_\_, and available at [www.sba.gov/wosb](http://www.sba.gov/wosb).”
- g. Will state that “The WOSB or EDWOSB must not misrepresent its certification status to any other party, including any local or State government or contracting official or the Federal government or any of its contracting officials.”

#### Withdrawal of Certification

The proposed Third Party Certifier’s certification process requires the Third Party Certifier to immediately withdraw a WOSB or EDWOSB certification if:

- a. The WOSB or EDWOSB no longer satisfies any of the requirements in 13 C.F.R. part 127 of SBA’s regulations.
- b. The WOSB or EDWOSB unduly delays, limits, or denies the Third Party Certifier access to the establishment, products, or records needed to verify compliance with the certification criteria.
- c. The WOSB or EDWOSB, or any of its officers or employees, engages in any improper actions in connection with the certification process, such as providing false information to the Third Party Certifier or SBA.

The proposed Third Party Certifier’s certification process requires the WOSB or EDWOSB to promptly notify the Third Party Certifier in writing of any new conditions that could cause the WOSB or EDWOSB to no longer satisfy the requirements set forth in 13 C.F.R. part 127 or of any intended changes to that may affect certification in the future.

The proposed Third Party Certifier’s certification process requires the Third Party Certifier to immediately notify SBA in writing if any certification has been withdrawn, as well as the basis for withdrawal.

The proposed Third Party Certifier’s certification process requires the withdrawal letter to the certified WOSB or EDWOSB to explain the following:

- a. The business concern is withdrawn as a certified WOSB or EDWOSB under the WOSB Program, effective on the date stated.

- b. The business concern will not submit an offer on or receive award of any WOSB or EDWOSB contract under the WOSB Program starting from the date of the withdrawal;
- c. The business concern will no longer be represented as a WOSB or EDWOSB in the Online Representations and Certifications Application and the Central Contractor Registration (CCR);
- d. The business concern is obligated by contract to complete all previously awarded WOSB or EDWOSB contracts, including modifications within the scope and price options which may be exercised

### Supporting Documentation

The proposed Third Party Certifier has a written policy of documentation management and retention evidencing the requirements below. Attached is such policy.

The proposed Third Party Certifier has the capacity to and will retain all of the documentation submitted by the certified WOSB or EDWOSB to the Third Party Certifier for a period of six (6) years from the date of initial certification, as well as any recertification. The proposed Third Party Certifier will maintain such documents in a permanent and secure system and will not allow Applicants (either before or after their applications are considered) to withdraw or modify supporting documents once submitted (but will allow additional documents to be submitted if the Applicant indicates that modifications were made in already-submitted supporting documents).

The proposed Third Party Certifier has a written policy addressing how it will handle WOSB and EDWOSB applications, documents, and any other materials received from the WOSB or EDWOSB as part of the certification process if the approved Third Party Certifier no longer processes applications, including the prompt manner by which it will deliver all such applications, documents and any other materials to the SBA and the efforts it will make to effect an orderly and efficient delivery to SBA. The written policy is attached.

The proposed Third Party Certifier has a mechanism for obtaining and will obtain authority from the Applicant and the certified WOSB or EDWOSB to provide SBA or any Federal Government entity (e.g., the U.S. Government Accountability Office) with any documentation relied upon for certification upon request by SBA or any Federal Government entity in response to a status protest, eligibility examination, performance review, investigation or audit in the timeframe specified.

The proposed Third Party Certifier has the following information available for review by SBA or any Federal Government entity (e.g., the U.S. Government Accountability Office) and will provide such information to SBA at any time requested after becoming an approved Third Party Certifier in the timeframe specified:

- a. Application screening and processing procedures
- b. Application documents and analyses
- c. All correspondence between the Applicant and the Third Party Certifier.

#### SBA Oversight

The proposed Third Party Certifier agrees to be subject to a performance review by SBA or any other Federal agency at any time, including, but not limited to, an administrative review consisting of an analysis of the data in the SBA tracking system and documents submitted to the SBA or a formal on-site visit initiated by SBA.

The proposed Third Party Certifier agrees to supply, in a timely manner, all requested information, files and documents to SBA or any other Federal agency in the timeframe specified for any evaluation or review of the Third Party Certifier and its process or compliance with this Agreement; and also for the evaluation of any certified concern. The SBA or any other Federal agency has the right to review all requested information in any and all formats available, including electronic and hard copy. The SBA or any other Federal agency has the right to enter any facility in which such requested information, files and documents are kept and review such materials.

The proposed Third Party Certifier agrees to immediately notify SBA of any change to its status as a national non-profit entity or in its certification requirements or documents submitted herein, as well as any change to any answer provided herein, that could cause the Third Party Certifier to no longer satisfy any of the requirements of this Certification.

The proposed Third Party Certifier agrees to provide SBA with a report on January 2nd of each year, or if that day falls on the weekend or a Federal Government holiday, then on the business day thereafter, stating that there have not been any changes to any of the answers provided in this Certification Form or the documentation provided thereto that could cause the Third Party Certifier to no longer satisfy the requirements of identified herein.

The proposed Third Party Certifier agrees SBA reserves the right to amend the requirements for the WOSB Program at any time. Revisions to the requirements may require termination of approval as a Third Party Certifier, modification of this Certification Form, re-approval of the Third Party Certifier and/or re-certification of existing certified WOSBs or EDWOSBs.

The proposed Third Party Certifier agrees that if it is uncertain about any requirement under 13 C.F.R. part 127, or SBA's interpretation of any requirement therein, it is the responsibility of the Third Party Certifier to seek clarification from SBA. In the event of any conflict between SBA's interpretation of its regulations and those of any the Third Party Certifier, SBA's interpretation shall control.

The proposed Third Party Certifier agrees, upon certification, to indemnify, defend and hold SBA, its officers, directors, agents, employees and other related parties harmless from and against any and all liabilities, damages, losses, expenses, claims, demands, suits, fines, or judgments that include reasonable attorneys' fees, costs and expenses, incidental thereto, which may be suffered by, accrued against, charges to or recoverable from any person or entity, by reason of any claim arising out of or relating to any act or error or omission, or misconduct of the Third Party Certifier, its officers, directors, agents, employees or subcontractors.

The proposed Third Party Certifier agrees that the SBA has the authority under 13 C.F.R. part 127 to conduct program examinations and protests on concerns that that have been approved by the Third Party Certifier and that SBA may find that these business concerns are not eligible.

The proposed Third Party Certifier agrees that it is an independent contractor and not an Agent as defined in 13 C.F.R. § 103.1; however, it agrees to comply with and that SBA shall apply the procedures set forth in 13 C.F.R. part 103 with respect to any proposed suspension and revocation of the Third Party Certifier's ability to accept, review, and examine applications for WOSB or EDWOSB certification, as well as to decline and withdraw WOSB and EDWOSB certifications.

The proposed Third Party Certifier agrees that, in addition to suspension and revocation pursuant to 13 C.F.R. part 103, SBA may terminate The Third Party Certifier Agreement, thereby

terminating the Third Party Certifier's authority to approve applications, for any of the reasons identified below:

- a. The Third Party Certifier fails to observe, perform, or fulfill any of the terms of this Agreement or its duties hereunder;
- b. The Third Party Certifier becomes insolvent;
- c. The Third Party Certifier's certification process does not comply with SBA-approved certification standards or is not based on the same EDWOSB or WOSB eligibility requirements as set forth in 13 C.F.R. part 127, as either of the foregoing may exist from time to time;
- d. Through one or more performance reviews of the Third Party Certifier, the SBA determines that the Third Party Certifier did not properly certify one or more WOSBs or EDWOSBs or failed to withdraw certification from one or more WOSBs or EDWOSBs; or
- e. Any other reason that SBA finds constitutes good cause for termination of this Agreement.

All the statements and information provided in this form and any documents submitted are true, accurate and complete.
