Graded Agency:

The Department of Justice (DOJ) is committed to maximizing opportunities for small businesses including SDBs, WOSBs, HUBZone firms, and SDVOSBs in its contracting. Despite a decrease in our procurement spending of almost \$600 Million compared with FY 2011 levels, DOJ increased the dollars awarded to small businesses in FY 2012 by more than \$57 Million. Further, DOJ increased the percentage of its dollars awarded in every small business socioeconomic category over FY 2011 levels. These efforts resulted in the Department exceeding its small business goal and its goals for SDBs and WOSBs in FY 2012. Also in FY 2012, DOJ awarded its highest ever total dollars and percentage of dollars to SDVOSBs. The Department recognizes the important role of small businesses in the successful delivery of its complex and critically important law enforcement and national security missions. The Department's leadership and its employees remain committed to the nation's small businesses to help carry out its missions in FY 2013 and beyond.
