The Department of Homeland Security (DHS) is honored to again receive high marks from the Small Business Administration (SBA) for the significant accomplishments made in our small business program. Since SBA started the letter grade Scorecard format in FY 2009, DHS has received a grade of "A" or "A+" seven years in a row, the largest federal agency to have such a track record. This recognition is a reflection of the department's strong commitment to providing opportunities for all types of small businesses to compete and win contracts in support of our vital mission to keep our nation safe. In FY2015, about 14,000 companies representing all 50 states, Washington DC, and five territories had DHS prime contracts. Of the 14,000, about 9,500 are small businesses; remarkably, of those 9,500, about 2,300 small businesses secured their first DHS prime contract.

It is with profound appreciation for the work of our small business partners and the men and women of this Department that we renew our commitment to continue working closely with the SBA to further develop our leading edge small business program at DHS.
